Notification

All provisionally selected pilgrims of Haj 2016 are hereby informed to deposit the first installment of Haj dues amounting to Rs.81,000/- (Rupees Eighty One Thousand Only) per pilgrim, either: -

1. Online at hajcommittee.gov.in or
2. In Haj Committee of India's Account No.32175020010 FEE TYPE-25 maintained with SBI or account No.318702010406009 (Haj Account) maintained with UBI through any branch SBI / UBI having Core Banking System latest upto **15th April, 2016**.

The pay-in-slip for the purpose has already been provided with the Haj Application Form. While depositing the money, Bank Reference Number, unique for each cover, has to be indicated (for example; for Cover No.JKR-1-2-0, the Bank Reference Number shall be 2016JKR1). The pilgrims can also download the pay-in-slips from the website of Haj Committee of India (www.hajcommittee.gov.in) or J&K State Haj Committee (www.jkshc.com). Besides, the Medical Screening & Fitness Certificate shall be obtained from a registered Medical Practitioner MBBS / Government Doctor. In case of difficulty the pilgrims can contact the office of the State Haj Committee or respective Deputy Commissioners.

The original pay-in-slips alongwith Medical Screening and Fitness Certificate shall be deposited in the office of respective Deputy Commissioners. However, pilgrims of district Srinagar shall submit these documents directly at Haj House, Bemina. In case any pilgrim fails to deposit the money upto **15th April, 2016** and submit the pay-in-slip and Medical Screening & Fitness Certificate by **23rd April, 2016**, in the respective Deputy Commissioners office or State Haj Committee office, his provisional selection shall be liable to cancellation without any notice.
