Subject:- Visit to Muqam-e- Shahwali Drugmulla on 06/07/2018.

The District Development Commissioner, Kupwara visited Muqam-e-Shahwali on 06/07/2018. Besides taking stock of developmental works and availability of essential supplies and services, he also visited the Ziyarat at Muqami Shahwali and check the

1. **Renovation of Spring near Dargah Muqam-e-Shah Wali:** ACD shall immediately take up renovation of spring at Muqam-e-Shah Wali while having full regard to aesthetics and workmanship. He may hire the services of a consultant for ensuring execution of quality work.
 2. **Completion of Toilet Block:** Director tourism is requested to ask the concerned engineers of the Tourism Department to complete the ongoing toilet block on immediate basis, keeping in view the forthcoming Urs on 19th-20th july. He is further requested to repair the existing Toilet Complex on emergent basis for the convenience of devotees.
 3. **Drainage:** ACD Kupwara shall take up the construction of drain around the shrine on most immediate basis.
 4. **Beautification of Area Adjacent to Shrine:** Director Tourism may consider the possibility of taking up beautification works at Dargah, Muqam-e-Shah Wali, Drugmulla on priority basis, keeping in view the rush of devotees which is witnessed at the said shrine.
 5. **High School Road:** Executive Engineer R&B shall take up improvement/black topping of High school road to mitigate the hardships of students.
 6. **Unsafe one School Building:** The unsafe building at High School Muqam-e-Shah Wali shall be dismantled forthwith by the concerned authorities after observing the codal procedure.

7. **Fencing Wall of HS Muqam-e-Shah Wali:** ACD Kupwara shall ensure completion of the fencing and other allied works at the High School Muqam-e-Shah Wali in one month. He will furnish action taken report.
8. **Labortary Block:** CEO Kupwara shall incorporate the construction of Laboratory Block in the Action Plan under SSA/RMSA.
9. **Sub Centre Muqam-e- Shahwali:** CMO Kupwara shall take upgradtion of Sub Centre Muqam-e-Shah Wali as Health & Wellness Centre on top priority.
